1. Information we collect

The NGT processes your personal information to meet its legal, statutory and contractual obligations and to provide you with membership information and services. We will never collect any unnecessary personal data from you and we do not process your information in any way other than as specified in this Notice.

The personal data we collect is:-

Home email address

Mobile number

Bank details for payment of subscriptions

We collect information in the methods below: -

From the Application Form you submitted when joining the NGT

From the Standing Order form you supplied for payment of your subscription

2. How we use your personal data

The NGT takes your privacy seriously and will never disclose, share or sell your data without your consent unless required to do so by law. We only retain your data for as long as it is necessary and for the purposes specified in this notice

The purposes and reasons for processing your personal data are detailed below:-

The NGT's bank for purposes of payments

Other bodies with whom it organises joint events (e.g. The Gardens Trust)

HM Revenue and Customs for Gift Aid purposes

For the purposes of supplying you with publications issued or supported by NGT

From time to time we will send you notices of events we have assessed may be of interest to you. Such information will be non-intrusive and is processed on the grounds of legitimate interest

3. Your rights

You have the right to access any personal information that the NGT holds about you and to request the following:-

What personal data we hold about you

The recipients to whom the personal data has been or will be disclosed

How long the NGT intends to store your personal data

If you believe that NGT holds any incomplete or inaccurate data about you, you have the right to ask us to correct and/or complete the information and we will strive to do so as quickly as possible, unless there is a valid reason for not doing so, at which point you will be notified

You also have the right to request erasure of your personal data and to restrict processing (where applicable) in accordance with data protection laws

If we receive a request from you to exercise of the above rights, we may ask you to verify your identity before acting on the request.

4. Events

The NGT will from time to time send you details of events it is arranging by post or email. You always have the right to opt out /unsubscribe at any time.
